ORDINANCE NO. 4 OF 2022**

**ORDINANCE TO APPROPRIATE \$1,200,000.00 FROM THE WATER CAPITAL  
IMPROVEMENT FUND TO PAY FOR A SEWER INFILTRATION AND INFLOW STUDY  
FOR THE BOARD OF WATER COMMISSIONERS OF THE CITY OF EAST ORANGE**

**WHEREAS**, the City of East Orange and its Board of Water Commissioners ("EOBWC") has determined that it is necessary for the effective operation of the East Orange Water Supply and Sewer Systems that it authorize and pay for the following out of the Water Capital Improvement Fund in the amounts as follows:

**WHEREAS**, in order to authorize and pay for the Sewer Infiltration and Inflow Study, it is necessary for the City Council of the City of East Orange to adopt an Ordinance appropriating One Million Two Hundred Thousand Dollars (\$1,200,000.00) from the Water Capital Improvement Fund to pay for the Sewer Infiltration and Inflow Study to be authorized and prepared for the EOBWC and to be funded by Water Capital Reserve Funds; and

**WHEREAS**, the EOBWC estimated the costs of said Sewer Infiltration and Inflow Study is approximately \$1,200,000.00 as set forth above and that there is sufficient funding available in the EOBWC Water Capital Improvement/Project Fund for authorization and payment of the same.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of East Orange that an appropriation of One Million Two Hundred Thousand Dollars (\$1,200,000.00) be made from the Water Capital Improvement Fund to pay for the preparation of a Sewer Infiltration and Inflow Study as provided above to be authorized and prepared for the Board of Water Commissioners of the City of East Orange to be funded by Water Capital Reserve Funds.

**BE IT FURTHER ORDAINED** that a copy of this Ordinance shall be filed with the City Clerk of the City of East Orange.

**Section One:**

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

**Section Two:**

That all ordinances and parts of ordinances and conflicts that are inconsistent with this ordinance are hereby repealed but only to the extent of such conflict or inconsistency.

**Section Three:**

This ordinance shall take effect after final passage and upon expiration of twenty (20) days following publication unless otherwise provided by resolution of this City Council.
