ORDINANCE NO. 9 OF 2021**

**ORDINANCE AMENDING CHAPTER 260 SECTION 14 OF THE CITY CODE
ENTITLED
“ALL-NIGHT PARKING PROHIBITED; EXCEPTIONS”**

SECTION ONE: (Amended Section only)

§260-14. All-night parking prohibited; exceptions.

C. Parking permits shall be issued on an annual calendar year basis ~~starting in from~~ January 1st through December 31st of each year. ~~Except as otherwise provided herein,~~ the annual parking permit fee shall be \$150 per year for each vehicle. The amount shall be prorated on a ~~quarterly~~ monthly basis. Monthly prices shall be as follows:

Monthly permit amounts shall be upheld for each day of the month.

The fee for residents over the age of 65 shall be ~~capped at~~ \$75 per year for each vehicle, regardless of the date of purchase of such permit. The fee for residents that have been deemed to be totally disabled by United States Government or the State of New Jersey shall be ~~capped at~~ \$75 per year for each vehicle, regardless of the date of purchase of such permit. All parking permit fees are nonrefundable. ~~Permits shall be issued for year long intervals starting from January 1 through December 31 of the year in which the permit application is made.~~ Payments must be made at the time of purchase ~~for either a 6 month or 12 month interval.~~ Permits are only transferable to a different vehicle owned by the same resident identified on the initial application.

SECTION 2: Severability of Ordinance Provisions

Each section of this Chapter is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

SECTION 3: Conflict of Other Ordinance Provisions

All ordinances and parts of ordinances that conflict or are inconsistent with this Chapter are hereby repealed only to the extent of such conflict or inconsistency.

SECTION 4: Effective Date of Ordinance Provisions

This Chapter shall take effect upon final passage and expiration of twenty (20) days following publication unless otherwise provided.
