

**THE CITY OF  
EAST ORANGE, NEW JERSEY  
ORDINANCE NO. 10 OF 2021**

**AN ORDINANCE AMENDING CHAPTER 5 ARTICLE IX SECTION § 5-70 OF THE  
CITY CODE ENTITLED “DUTIES OF DIVISIONS; DIVISION MANAGERS;  
ADDITIONAL PERSONNEL”**

**WHEREAS**, by Ordinance of 2015, the Division of the East Orange Golf Course was transferred from the East Orange Department of Recreation to the East Orange Department of Public Works; and

**WHEREAS**, the fee structure for the East Orange Golf Course was revised via Ordinance No. 22 of 2015 and also transferred to the East Orange Department of Public Works; and

**WHEREAS**, it is desirous of the City Council to allow flexibility in the marketing and promoting of the East Orange Golf Course via promotions and specials; and

**WHEREAS**, said promotions and specials may require the ability of the Golf Course Superintendent to reduce or waive fees.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of East Orange that the Code of the City of East Orange is hereby amended as follows:

**SECTION 1: (Amended Section Only)**

**§ 5-70 Duties of divisions; division managers; additional personnel.**

**M. The Division of the East Orange Golf Course shall:**

- (1) Be responsible for the development and implementation of golfing and other community-oriented activities and programs at the East Orange Golf Course.
- (2) Be responsible for the sound and fiscally responsible management and operation of the East Orange Golf Course.
- (3) Charge the following fees in connection with the East Orange Gold Course. [Added 12-23-2015 by Ord. 56-2015]

- (a.) East Orange residents/employees receive a twenty-five percent discount on season passes.
- (b.) All season passes are through tee times.
- (c.) All season pass holders must pay the nine-hole cart fee for the use of carts.
- (d.) League Membership must be pre-approved by the submission of application prepared by the Golf Course manager of the City of Eat Orange for up to 40 golfers whose names must be submitted with the original application along with a fee of \$8,780. For each additional golfer over 40 in number, there shall be an additional charge of \$210.
- (e.) Tournament fees. There must be a minimum of 80 players. The cost per player, which includes a golf cart, is \$60.00 per player, Memorial Day through Labor Day, and \$40.00 per player after Labor Day. Also, a non-refundable deposit of \$500 is required to schedule and book the date.
- (f.) Upon the consent of the Department of Public Works (DPW) Director and City Administrator, the East Orange's Golf Course Superintendent may reduce green fees to run special promotions or events for the East Orange Golf Course.

**SECTION 2. SEVERABILITY OF ORDINANCE PROVISIONS**

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

**SECTION 3. INCONSISTENCIES**

That all ordinances and parts of ordinances and conflicts that are inconsistent with this ordinance are hereby repealed but only to the extent of such conflict or inconsistency.

**SECTION 4. EFFECTIVE DATE**

That this ordinance shall take effect upon final passage upon expiration of twenty (20) days following publication unless otherwise provided.
